*Exceptions

- **R-1, R-3, R-4, R-R** For community centers, churches or schools the side yard setbacks shall be double required for the district, but not greater than 30 feet.
- R-3- Side yard setbacks shall not be less than 30 feet when abutting an R-1 district.
- R-R -If abutting a public right of way, side yard setbacks shall not be less than 30 feet.
- **R-B** For nursing homes or similar group homes, side yard setbacks shall be double required for the district, but not greater than 30 feet.
- B-1, B-2, B-3, B-4- If abutting a R-1,R-2, or R-3 district, side yard setbacks shall not be less than 25 feet.
- I-1- Side and rear yard setbacks shall not be less than 50 feet when abutting an "R" district.
- I-2- Side and rear yard setbacks shall not be less than 100 feet when abutting an "R" district.
- **I-2** Different provisions apply if zoned prior to 9-21-1972.
