

ORDINANCE NO. 73, FOURTH SERIES

**AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE
CODE OF ORDINANCES FOR THE CITY OF REDWOOD FALLS**

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio, completed the Eleventh Supplement to the Code of Ordinances of the City of Redwood Falls, which supplement contains all Ordinances of a general and permanent nature enacted since the prior supplement to the Code of Ordinances of the City of Redwood Falls;

**NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE
CITY OF REDWOOD FALLS:**

SECTION 1. That the Eleventh Supplement to the Code of Ordinances of the City of Redwood Falls, as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, which includes Ordinances:

- 71 AN ORDINANCE AMENDING REDWOOD FALLS CODE OF ORDINANCES §4.07, AND REPEALING ORDINANCE NO. 124, THIRD SERIES, ADOPTED ON MARCH 3, 2009, TITLED "AN ORDINANCE ADOPTING THE 2006 EDITION OF THE INTERNATIONAL PROPERTY MAINTENANCE CODE."

and all other amendments, be and the same is hereby adopted by reference as if set out in its entirety; and

SECTION 2. Such supplement shall be deemed published as of the day of its adoption and approval by the Legislative Authority, and the Clerk of the City of Redwood Falls is hereby authorized and ordered to insert such supplement into the copy of the Code of Ordinances kept on file in the Office of the Clerk.


