

This rate schedule is furnished for your information and convenient reference. The complete rate schedule, rules and regulations pertaining to them are on file at City Hall and are available for inspection.

## BILLING

All bills are rendered monthly and are **DUE UPON RECEIPT**. If payment is not received at the Utilities' Office by the due date printed on the bill that account shall be assessed a late payment penalty of 10% of the amount of the current bill.

## DELINQUENCY

Any utility bill, which is not paid by the due date, shall, upon written notice, be disconnected without further notice. If you dispute the amount due, you may request a hearing before the Redwood Falls City Council. If disconnection of service is made, the following sums shall be charged for the re-connection of service for each utility: \$50.00 for Electric and \$50.00 for Water if the re-connection is made during the hours of 8:00 a.m. – 4:00 p.m. or \$120.00 for each utility service if re-connection is made after 4:00 p.m. or on weekend between 8:00 a.m. – 8:00 p.m. No re-connections will be done after 8:00 p.m.

## DEPOSITS

A \$250.00 utility service deposit or letter of credit, a completed utility application and a copy of photo identification for each applicant is required for **ALL accounts**. Please refer to the City of Redwood Falls Public Utilities Customer Policies and Procedures pamphlet for further explanation.

## ELECTRIC RATES

*Resolution No. 60 of 2018*

*Effective 01/01/2019 for electricity billed in January 2019 and payable in February 2019*

### **RESIDENTIAL SERVICE:**

- \$14.85 Flat customer charge
- \$0.091 Energy per KWH

### **COMMERCIAL SERVICE:**

- **SMALL COMMERCIAL** (demand is less than 49 KW)
  - \$21.20 Flat customer charge
  - \$0.100 Energy per KWH
- **LARGE COMMERCIAL** (between 50-249 KW demand)
  - \$32.00 Flat customer charge
  - \$12.25 Per KW Demand
  - \$0.040 Energy per KWH

### **INDUSTRIAL SERVICE** (*Demand is more than 250KW*):

- \$32.00 Flat customer charge
- \$11.75 Per KW Demand
- \$0.040 Energy per KWH

## **ENERGY COST ADJUSTMENT BASE:**

- \$0.0436 (effective 01-01-2019)

## **SECURITY LIGHTING:**

- \$5.35 per light per month (only in City limits)

## **AREA LIGHTING:**

- \$ 5.35 Per 100 watt light per month
- \$ 9.43 Per 150 watt light per month
- \$12.47 Per 250 watt light per month
- \$16.20 Per 400 watt light per month
- \$35.61 Per 1000 watt light per month

## **WATER, SANITARY SEWER & STORM SEWER RATES**

*Resolution No. 41 of 2019*

*Effective 01/01/2020 for water, sanitary sewer and storm sewer changes billed in January 2020 and payable in February 2020*

### **WATER SERVICE:**

- \$150.00 Hookup fee for new service
- \$ 5.80 Per 100 cubic feet per month
- \$ 12.14 Per meter for monthly base charge

### **SEWER SERVICE:**

- \$150.00 Hookup fee for new service
- \$ 3.34 Per 100 cubic feet of water used for monthly usage charge
- \$ 10.33 Per meter for monthly base charge

### **STORM SEWER SERVICE:**

- \$ 9.08 Per (1) Residential Equivalency Factor (REF)
